

**Orchard View Elementary School
Parent and Family Engagement Policy
2020-2021**

Orchard View Elementary School jointly developed this parent and family engagement policy in consultation with school personnel, community members, and parents. A list of committee members responsible for the writing of this policy can be found in Appendix A. This policy was distributed to parents of participating children and to the extent practicable, provided in a language the parents can understand. This policy shall be made available to the local community through the school web page. If the Title I plan (application) is not satisfactory to the parents of participating children, Frederick County Public Schools will submit any parent comments with the application when the plan is submitted to the state. This parent and family engagement plan will be updated annually to meet the changing needs of parents and the school.

Part 1. POLICY INVOLVEMENT

Orchard View Elementary School will:

- (1) Hold a virtual information session to which all parents shall be invited and encouraged to access, to inform parents of their school's participation in Title I and to explain the requirements of Title I, and the right of the parents to be involved;
- (2) Offer a flexible number of meetings. A schedule of this year's meetings can be found in Appendix B;
- (3) Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of the school's Title I program, including the planning, review, and improvement of the school parent and family engagement policy.
- (4) Provide parents of participating children:
 - (A) timely information about Title I programs;
 - (B) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet; and
 - (C) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.

Part 2: BUILDING CAPACITY FOR INVOLVEMENT

To ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, Orchard View Elementary School and Frederick County Public Schools assisted under this part:

- (1) shall provide assistance to parents of children served by Orchard View Elementary School and Frederick County Public Schools, as appropriate, in understanding such topics as the state's academic content standards and State student academic achievement standards, state and local academic assessments; also monitor a child's progress and work with educators to improve the achievement of their children;
- (2) shall provide materials and training to help parents work with their children to improve individual achievement, such as literacy training and using technology, as appropriate, to foster parental involvement;

- (6) may pay reasonable and necessary expenses associated with local parent and family engagement activities, including transportation and child care costs, to enable parents and families to participate in school-related meetings and training sessions;
- (7) may arrange school meetings at a variety of times, between teachers and other educators who work directly with participating children, in order to maximize parent and family involvement and participation;
- (8) may adopt and implement model approaches to improving parent and family engagement;
- (9) will establish a division wide parent advisory council to provide advice on all matters related to parent and family engagement in programs supported under this section;
- (10) may develop appropriate roles for community-based organizations and businesses in parent and family engagement activities; and
- (11) shall provide such other reasonable support for parent and family engagement activities under this section as parents may request.

Orchard View Elementary School, to the extent practicable, shall provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, in a format that is practicable and in a language that parents can understand.
